PROPOSTAS DE OPERACIONALIZAÇÃO CONCEITUAL**

**OBJETIVO (S) DO COMPONENTE**

Esta disciplina pretende discutir o modo como as ciências da saúde, em particular a epidemiologia, utilizam as noções de raça e racismo para realizar estudos populacionais. Na Introdução da disciplina, será explorada a relação entre teoria e método nas ciências, com uma discussão específica sobre modelos e mecanismos. Na Primeira Parte, será discutida a incorporação de raça e racismo em teorias científicas a partir de processos históricos, sociais e políticos de racialização e de opressão. Na Segunda Parte, será analisada a operacionalização conceitual do racismo nas ciências da saúde por meio de modelos e métodos desenvolvidos na literatura, como determinantes sociais e políticos, teorias biopsicossociais e análise multinível.
